Photography • Original Prints • Drawing • Painting • Watercolor • Pastel • Video

**DESCRIPTION:** There will be no jury process associated with this exhibit; this is an open invitation exhibit open to all interior Alaskan artists. Each artist is allowed **two entries which must be no larger than 36 inches in any direction** (this includes the size of the frame/mounting). Entries must be portraits (self-portraits or otherwise) and artists are encouraged to explore the history, implications, and alternate interpretations of portraiture as a genre.

### ELIGIBILITY:

- Entries submitted only by the artist & limited to two entries. Artwork entries must be defensible as portraiture.
- Only artists residing in the Interior of Alaska, Doyon Region may submit.
- Original artwork only. Work must reflect the artist's unique creative effort.
- No kits. No copies or exact replicas of other original artwork or published artwork (***No copies of any published images or copyrighted characters, i.e. Disney.***)
- Work must have been completed **within the last two years** and not previously exhibited in the BEAR GALLERY.

### CONDITIONS:

- Selected entries remain on display through Saturday, January 28, 2016.
- Entries will be handled with the greatest possible care and are insured against damage or loss for the duration of the exhibit. FAA is not responsible for minor wear resulting from normal handling.
- FAA retains a 35% commission on all exhibit sales. Works will be for sale unless noted as NFS (Not for Sale). Payments will be made to artists within 30 days of the exhibit's closure.
- Submitting an entry constitutes agreement on the part of the artist to all conditions in this prospectus.

### INSTRUCTIONS:

- Entries must be ready for display, matted (optional) and framed.
- Works to be hung on the wall must have wire hangers. **NO SAWTOOTH HANGERS.**
- Unusual hanging mechanisms must be approved by the Visual Arts Coordinator.
- Quilts must have 2 inches of Velcro stitched along the entire top: **NO VELCRO, NO ACCEPTANCE.**
